The performance of the transport sector is top on the national priorities of Governments in East & Central Africa. Substantial investments are needed in new roads upgrading projects, new railway networks and corridor projects.

In Tanzania's 2025 Development Vision, investments in infrastructure, particularly in the development of the road & rail network, are the Government's top priority.

Completion of the Standard Gauge Railway (SGR) would link Tanzania to Burundi and Rwanda as well as to the DRC and Uganda.

"We built a world-class railway... because we knew that in building world-class manufacturing and value addition investments — which are critical to creating jobs — we would need world-class infrastructure."

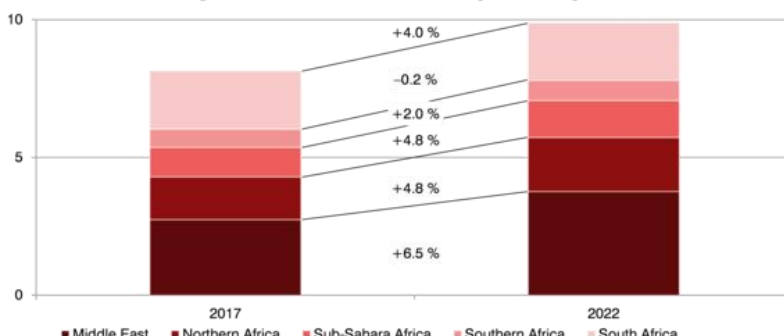

"A 40ft container costs US\$3,500 from Mombasa to Kampala by road compared to US\$1,500 by rail when the standard gauge railway is ready, and it will only take one day. A similar container on the Peking (Beijing) - Shanghai line would cost US\$1,500 for transport. That is why we are working for the standard gauge railway. It is in order to lower the costs of doing business in our economy so that we attract more businesses."
